

Statutes from 149 WIPO Member States

Diversity

- historical influences;
- regional agreements e.g. EU;
- cultural and economic values;
- political realities;
- competing interests.

Statutes from 149 WIPO Member States

- No exception for libraries or archives 21 countries
- General exception only 27 countries
- Copying for Research or Study 74 countries
- Copying for Preservation 72 countries
- Copying for Replacement 67 countries
- Document supply 17 countries
- ILL 6 countries
- Anti-circumvention measures 26 countries



Diversity in preservation provisions

Criteria

- single or multiple copies;
- from or for the Permanent Collection of the library;
- available on the market for purchase,
- in some cases the library has to certify that the copy is not reasonably available.

Conditions included

- the condition of the work;
- if the work has already been lost, damaged or stolen or
- if it is to protect the work against loss or deterioration.

Key findings

- Most countries have at least one statutory library exception
 Broad recognition of the vitality of libraries and archives
- Exceptions not updated for technological change
 While most countries have a prohibition on circumvention, only 26 countries had a library anti-circumvention provision

Treaty Proposal on Copyright Limitations and Exceptions for Libraries and Archives

IFLA is working with WIPO Member States to gain support for a binding international instrument on copyright limitations and exceptions to enable libraries to preserve their collections, support education and research, and lend materials.

To demonstrate what is needed, IFLA, together with the International Council on Archives (ICA), Electronic Information for Libraries (EIFL) and Corporación Innovarte, has produced the Treaty Proposal on Copyright Limitations and Exceptions for Libraries and Archives, (TLIB), to guide WIPO's Member States in updating limitations and exceptions for libraries worldwide.

TLIB is intended as a constructive proposal to feed into the discussions at WIPO.

The limitations and exceptions mandated by the Treaty proposal are based on a set of principles that were developed in 2009 by librarians, intellectual property specialists, the World Blind Union, and representatives of other civil society NGOs.

It governs the use of all copyright works and also of all materials protected by related rights, according to national law. It applies to materials in any format, digital and non-digital.

The Treaty proposal covers:

- * Parallel importation (i.e buying books from abroad)
- Cross-border uses of works and materials reproduced under a limitation and exception
- * Library lending
- * Library document supply
- * Preservation of library and archival materials
- Use of works and other material under related rights for the benefit of persons with disabilities
- * Use of works for education, research and private study
- * Use of works for personal and private purposes
- * Access to retracted and withdrawn works

SCCR/23 identified 11 topics related to libraries and archives

- preservation
- right of reproduction and safeguarding copies
- legal deposit
- library lending
- parallel importation
- cross-border uses
- orphan works, retracted and withdrawn works & out of commerce works
- limitations on liability of libraries and archives
- technological measures of protection
- contracts
- right to translate works
